Important Information:

- Under the new terms for the holiday period, if you book for any sessions that fall within the 2nd – 7th January 2025, you will still incur the same charges if are attempting to cancel after 1 PM on December 20, 2024, regardless of the 7-day notice rule.
- For bookings on December 23 or 24, 2024, you must cancel by the normal 7 days' **prior** notice to avoid charges.
- So, if you cancel on December 27, 2024, for a January 6th 2025 booking, you will be charged because it falls after the cutoff date.
- Our office, including the enrolment and management teams, will be closed on 23rd and 24th December 2024, and 2nd and 3rd January 2025. Emergency arrangements are in place.
- Our enrolment and management will return on Monday, 6th January 2025, with enrolments available from 8:30am. The app will be available for booking January sessions, provided they don't fall within the 7-day **prior** notice period.

- Please submit bookings for **23rd and 24th December 2024**, as well as **2nd, 3rd, 6th, and 7th January 2025** by 1pm on Friday, 20th December 2024. This applies to bookings within the 7-day notice period or those not already made via the My Family Lounge App.
- Bookings received by 1pm on 20th December for the **bold specified period** above will be confirmed via email by 4:30pm the same day. Requests outside this timeframe may not be accommodated.
- Emergency care bookings can be arranged at the service, subject to availability and late booking fees.
- All other terms and conditions outlined upon enrolment will apply.
