

## **ACT Pre-Learner Licence Course Information & Enrolment Form**

The ACT Pre-Learner Licence Course (PLLC) is more than just a training session for people to learn about the ACT road rules. Knowing the road rules is important, but so is knowing how to be a safe, accountable, and responsible member of the ACT road user community. The course is a classroom style education program that is required to be completed by ACT residents applying for an ACT Learner Licence (L's) as part of the graduated licencing scheme.

The course is made available by the Youth Engagement Team (YET) to all young people aged 15 - 25 years and is facilitated by trained staff over 2 consecutive days. Attendance of both days and a final multiple-choice assessment is compulsory in order to successfully complete the course. Once the course is completed, an online Road Rules Knowledge Test is required and will be facilitated on the afternoon of the second day.

The course has been designed based on world's best practice learner driver education and will help prepare young and inexperienced drivers in the ACT to become safer and more responsible drivers. The material incorporates content and activities which will allow young people to learn more about how having a licence should be considered a privilege that they should respect by being accountable, responsible, and safe road users.
